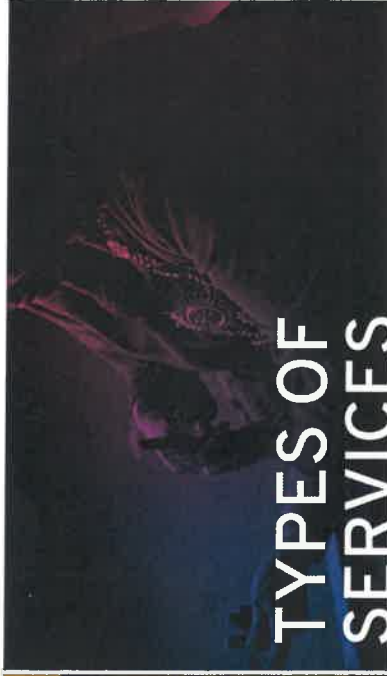


## TREATMENT CENTERS

## NAVAJO REGIONAL BEHAVIORAL HEALTH AUTHORITY

Navajo Behavioral Health Authority (NRBHA) provides care coordination services for Navajo People with a serious mental illness that impairs their ability to function in the community.

### Documents required for enrollment in program:

- Arizona AHCCCS enrollment under Behavioral Health
- Physical Examination within last 30 days (TB Skin Test/Result)
- Immunization Record
- Evaluation within (30) days: Psychiatric for Mental Health and/or Substance Abuse Assessment
- Certificate of Indian Blood
- Social Security Card
- Photo ID or Driver's License
- Map to physical address
- Court Documents (copy of court order, probation agreement, etc.)
- Child Protective Service Documents (Parent/Guardian/Child(ren) involved with Family Services-Social Services)
- School Grade Report, Incident Reports (anyone under age 18 years old)
- Marriage License (for applicants who are non-native, but married to an enrolled Native American)

Any missing information will be considered an incomplete referral.
